### 4. First-Aid Measures

#### **General advice:**

First aid providers should wear personal protective equipment to prevent exposure. Remove contaminated clothing. Move person to fresh air. Treatment:

# 6. Accidental release measures

#### Personal precautions:

Take appropriate protective measures. Clear area. Shut off source of leak only under safe conditions. Extinguish sources of ignition nearby and downwind. Ensure adequate ventilation. Wear suitable personal protective clothing and equipment.

#### **Environmental precautions:**

# 7. Handling and Storage

#### Handling
